

## Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, October 4-10, 2021, naming BOMA International (BOMA) (1101 15th Street, NW Suite 800, Washington, DC 20005) as the certificate holder. The following must be named as additional insured: BOMA International and the Office Building Show, LLC, Boston Convention & Exhibition Center (BCEC), Show Management Solutions, Inc., Stamats Communications and Freeman.

BOMA International has requested that Rainprotection serve as their insurance management company. In addition to being able to provide exhibitors with insurance, we are also collecting and verifying that all insurance certificates, regardless of the insurer, are verified for compliance.
